

FOREIGN INVESTMENT BUSINESS LICENSE (AMENDMENT) ACT, 2020

AN ACT to amend Title 36, Chapter 2 of the Marshall Islands Revised Code, the Foreign Investment Business License Act 1990, to amend the civil penalty for violations under this Chapter.

BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

§101. Short title.

This Act may be cited as the Foreign Investment business License (Amendment) Act, 2020.

§102. Amendments.

Section 208A of the Foreign Investment Business License Act 1990 is hereby amended to as follows:

§208A. Civil Penalty.

In addition to the provisions of section 208 and 211 of this Chapter, any person who violates a provision of this Chapter shall be liable to a monetary penalty in an amount no exceeding fifty thousand dollars (\$50,000).

Section 211 of the Foreign Investment Business License Act 1990 is hereby amended to as follows:

§211. Prohibited Acts.

Any non-citizen, as defined in this Chapter, who does business without first obtaining a business license, or who after obtaining a license does business not authorized by the license or intentionally fails to comply with the conditions of the offense and shall upon conviction be liable to a term of imprisonment not exceeding twelve (12) months or a fine not less than ten thousand dollars (US\$10,000), or both.

§103. Effective date.

This Act shall take effect in accordance with the Constitution and the Rules of Procedures for the Nitijela.
